## Panel I: Risks of U.S.-China Strategic Competition

40 years after the normalization of ties, China and the U.S. stand at a new historic turning point in their bilateral relationship. Despite labelling China as a "revisionist power" and an "economic aggressor" in 2018, the Trump Administration stands on the cusp of a landmark, next-generation trade and investment agreement with Beijing. The two sides also continue to march in lockstep to denuclearize the Korean peninsula. Was the harsh rhetoric of 2018, then, an anomaly? Or is it a precursor to a markedly tougher U.S. approach to bilateral ties in the months and years ahead? What are the key friction points in ties during these last two years of the Trump Administration? And what are the risks for Asia and the world that could stem from bitter and insoluble China-U.S. strategic rivalry?

## Panel II: U.S.-China Cooperation in a Global Context

China and the U.S. face myriad global challenges, none of which are amenable to resolution at a purely national level. Climate change, pandemics, piracy, overfishing, migration, and transnational crime, including the trafficking of illicit drugs, do not respect national boundaries. Concerted global action is essential, especially at a time when a dark cloud hangs over the notion of multilateral cooperation itself. Given the emerging outlines of strategic rivalry in China-U.S. ties, cooperation on global and multilateral challenges offers a pathway forward to stabilize this critical bilateral relationship. Can China and the U.S. find common purpose in addressing these global challenges and seize the opportunities therein, including in Africa where both countries share an interest in the continent's development and prosperity?
