FROM THE EXECUTIVE DIRECTOR

Dear Friends.

On behalf of the ICAS board of directors and advisors, I am excited to share with you this brief snapshot of our accomplishments in 2020.

2020 has gone down globally as one of the most difficult years in recent history. As news of COVID-19 began to spread in the early months of the year, nobody could have foreseen the devastation it would bring. The U.S.-China relationship was also not immune to this virus as the world began to shut itself down. Tensions between the two countries rose over the World Health Organization's engagement with China. Rather than finding ways to cooperate and take on the impacts of the virus together, the two countries further shut each other out of the conversation. The positive momentum created by the signing of the Phase One Trade Deal seemed to evaporate in an instant.

As we continue living with the pandemic in 2021, there is still much uncertainty before us. And yet, I am hopeful, with the new Biden administration's pledge to reengage with the rest of the world, doors that had been previously shut have a chance to be reopened. From addressing climate change to helping end the pandemic globally through vaccination initiatives like COVAX, the United States and China have an opportunity and shared interest to help put the world back on the path of prosperity. Biden's returning to multilateralism and China's continuing to uphold multilateralism is a key platform to address the challenges of global governance and for advancing views on how the world can act together to propel collaboration. It also creates an opportunity for China and the United States to shift the bilateral relations from rivalry to cooperation in many of the global agendas.

When the pandemic struck and forced us to work remotely, ICAS, like many institutions, was forced to reassess its prioritizations. Yet, we would not be deterred. ICAS continually strived to provide a window into the worldviews of both the United States and China, and thereby serve as a vehicle to promote greater understanding between these two countries and societies. In addition to publishing dozens of analyses, ICAS also proudly released its Arctic Maritime Tracker project and updated its South China Sea Maritime Tracker to help viewers better understand the ongoing tensions in the region. ICAS released a special project related to the COVID-19 pandemic as it unfolded in order to better understand its varied and extensive impacts to the U.S.-China bilateral relationship. Additionally, the whole ICAS team was proud to have participated in researching and writing the China chapter for the Ocean Law Encyclopedia to be released next year.

The pandemic did not stop ICAS from engaging with the world and ensuring that pertinent analysis was conducted on the U.S.-China relationship. Even as we continue to work remotely for the foreseeable future, I am eager to see what we can continue to achieve with your support.





n December 3rd, the Institute for China-America Studies (ICAS) organized its 2020 Annual Conference. Given the raging COVID-19 virus, the conference was conducted virtually, with almost 350 participants tuning in from both sides of the Pacific. The conference was inaugurated with brief introductory remarks by the chairman of ICAS' advisory board, Dr. Wu Shicun. In his remarks, Dr. Wu was candid that U.S.-China ties were currently scraping the bottom; however, he expressed hope that President-elect Joe Biden would once again return the bilateral relationship to a more normalized track of dialogue and engagement. Mr. Biden's multilateral over unilateral approach was positively evaluated and appreciated.

Dr. Wu's remarks were followed by the highlight of the conference - a keynote dialogue featuring China's longstanding and well-respected Ambassador to the U.S., Amb. Cui Tiankai, and Dr. Graham Allison, the Dillon Professor of Government at Harvard University. The dialogue was moderated by Mr. Stephen Orlins, President of the National Committee on U.S.-China Relations.

The Keynote Dialogue was followed by two panels focused on the outlooks for U.S.-China strategic rivalry and U.S.-China engagement on trade, technology, and the environemnt at the turn of a new U.S. presidency.

ICAS co-hosted two private events with the National Committee on U.S.-China Relations and the National Institute for South China Sea Studies. Established in October 2012, the purpose of this dialogue is to convene American and Chinese legal experts to explore the issues surrounding China's recent maritime disputes and escalated tensions in both the South China Sea and the East China Sea in order to better understand their impact on China's relationships with its neighbors and U.S.-China relations, while at the same time provide suggestions for improving the management and settlement of current maritime disputes.

This year, regional experts explored the role of United States and China in rules making and security mechanism building in the maritime domain and how circumstances might change under a Biden administration.





Introducing the Arctic Tracker



South China Sea Tracker Phase II








ICAS has identified the Arctic as an important area of study in assessing both the competitive and the cooperative relationship between the U.S. and China. In early 2020, ICAS expanded its Maritime Trackers

project by adding the Arctic as a region of interest and is building this issue tracker as a part of our commitment to ensuring that the public, researchers, and policymakers have easy access to the latest





updates regarding the Arctic Ocean.

Arctic Tracker Phase I

The scope of the first phase of the Arctic tracker focuses on two major aspects:

- Internationally submitted maritime claims as well as national legislation on maritime rights.
- Air power projection of the major Arctic military powers (the United States, Russia and Canada).

The individual and combined interactive Air Power Projection tracker maps explore the extent of military air power projection possessed by the U.S., Russia and Canada in the Arctic Region as well as their known regional strategies.




